Committees to look into violations of agreement

The government has proposed to the Liberation Tigers of Tamil Eelam (LTTE) the setting up of Committees to deal with any violations of the agreement of the cessation of hostilities which will come into force shortly These Committees will consist of government, LTTE and foreign representatives and during the second round of peace_negotiations held with the Tigers in Jaffna on Tuesday there was general agreement on this mat- . ter, Minister of Media, Tourism and Aviation

and Cabinet spokesman, Dharmasiri Senanavake announced at yesterday's Cabinet news conference at

Visumpaya.

Quoting a communique from the Presidential Secretariat, the Minister said that details of implementation of the cessation of hostilities were discussed at length during the talks and most issues were resolved satisfactorily. The date on , which the cessation of hostilities will commence and other details will be announced hortly. The communique indicated that the government delegation which reached Jaffna on Tuesday for the second round of discussions was very cor-dially received by the LTTE. The talks centred around several major issues. The next round of peace talks is scheduled to resume on January 14 in Jaffna.

On the opening of access routes to and from Jaffna the government team suggested that two access routes be opened to and from Jaffna, i.e., Elephant Pass and Sangupiddy.

The opening of the Elephant Pass roadway was proposed with the

objective of facilitating the movement of heavy vehicular traffic re-quired for the reconstruction of the Northern region, and for the economical and speedy transport of food supplies.

The government also believed that the opening of this road would enable the pilgrims from the North to participate in the ceremonies connected with the visit of His Holiness

the Pope.

No agreement could be reached on this issue as the LTTE

stipulated the conditions that the Army Camp at Pooneryn be completely withdrawn. The government could not agree to this at present, due to the prevailing military situation in the North.

Where rehabilitation and development of the north are concerned the government proposed a comprehensive package of rehabilitation and development of the Northern region at a total estimated cost of Rs. 40 Billion, over a period of years.
