Where were you, Mr. Thondaman?. (1994, October 22). The Island.

Where were you, Mr. Thondaman?

A decade of agony in my mind and heart burst into laughter when I read a news item, in a National Tamil Daily, about a week after the grooming of the new Madam Prime Minister that Mr. Thondaman. had congratulated the Madam Prime Minister on behalf of not only the Plantation Tamils but also on behalf of all Tamils in Sri Lanka. I was happy that he had not taken the onus of congratulating on behalf of the Tamils in the whole world and the

other communities of this country. At the outset, may I ask Mr. Thondaman as to what moral right, rhyme or reason he has got to speak on behalf of all Tamils, particularly those of Northern and Eastern Provinces, leave along the Sri Lankan Tamils living outside these provinces and whether he can claim to have the sole right to speak on behalf of the entire Plantation Community.

I say 'NO' to both these questions for the

following reasons:-1. When the great leader Mr. S. J. V. Chelva-nayagam found the TULF in an attempt to unite all Tamils in Sri Lanka, offering an equal place to Mr. Thondaman in the Presidium along with him and late Mr. G. G. Ponnambalam, Mr. Thondaman having accepted, at the spur of that moment, in front of a large gathering, declined in a short time, to the surprise of many, to continue in that office, giving a lame excuse, that the problems of the people he was representing was quite alien to that of other Tamils in Sri Lanka and as such he was not prepared to continue in that position. Though, I do not agree with this false and dubious view of Mr. Thondaman, I ask him now, as to what he has done since then, for the other Tamils to speak on their behalf.

(a) When hundreds of people were chopped to death in the Kumudini Launch taking innocent passengers to the Island Delft from the Jetty of Kavts.

(b) When nearly a hundred detainees in the custody of the law enforcing authorities, in prison, were murdered in 1983.

(c) When hundreds of workers were thrown out of employment leading to suicide by some of them after the strike in 1980.

(d) When thousands of people were rendered homeless, became refugees and living in most trying conditions. (e) When thousands of innocent lives were lost

due to indiscriminate bombarding and shelling in the North and East.

(f) When thousands of dwelling houses, business establishments and many a place of worship were burnt and destroyed along with the lives of the inhabitants.

(g) When hundreds of innocent fishermen were

done to death when they went to the sea, to earn their livilihood.

(h) When thousands of wage earners like carpenters, masons and other categories including fisher-

(i) When thousands of innocent people were taken into custody and reported either missing or no knowledge of them.

(j) When the people of North were denied the basic essential requirements of electricity and fuel for more than three years with a litre of kerosine oil sold as high as Rs. 300/-

(k) When people died for want of essential medicines.

(I) When the farmers were denied their require-ments of fertilizer and agro-chemicals for their cultivation.

(m) When people including pregnant mothers, the old and the disabled had to go through the 'hell' in Nochchimoddai, Thandikulam etc. in their movement to and from the North to the South. (n) When incidents like what happened in Kok-kaddichcholai took place.

(o) When a number of youth and school boys in the South particularly in places like Embilipitiya and Suriyakanda were snatched away from their parents and massacred.

(p) When stones were pelted at residences of Judicial Officers.

(q) When black marketeering was done in food items including essential ones rendering the common man out of reach to these items and partial starvation.

(r) When oppressive legislation like Prevention of Terrorism Act etc. was enacted to curb the democratic freedoms of the people.

(s) When Chandrasekaran, an elected representative of the people was deprived of attending the meeting of the provincial council, and subjected to various odds.

Now, Mr. Thondaman cannot deny the fact that these atrocious acts did not bother him at all as otherwise he would have at least raised his voice for the 'glory of it' as, he did when communalism was frothen out during the time the 'famous' vote of no-confidence was brought in against the then Leader of the Opposition late Mr. Amirthalingam and since he did not spare the government with the threat of resignation in the

instant off his 'petty quarrel' with his erstwhile comrade Sellasamy. Apart from the above, he has also played a

Even as far as the plantation communis concerned Mr. Thondaman would have itv achieved all that he boasts as his 'achievements' in the UNP government, forty years ago, when he was the uncrowned King of the plantation com-granity, if he had an honest desire. But, he thought otherwise, that those poor plantation workers would have joined other leftist Trade Unions led by leaders like Dr. N. M. Perera, Dr. Colvin R. de Silva and Dr. S. A. Wickramasinghe, if they got their rights like citizenship.

There is much more to Mr. Thondaman's 'credit' but let me conclude by reminding Mr. Thondaman of the old saying, one can fool (cheat) all people sometime, some people all times, but not all people at all times. As such, I request Mr. Thondaman to keep aloof from the people of the North/East and their problems.
